#### 5.3 Landscape Disturbance

#### 5.3.1 Forest Productivity

The forest productivity classes of 'Treed', 'Cutblocks', 'Recent Burns', 'Natural Non-Forested' and 'Anthropogenic Non-Forested' are summarized in this section.

The 'Treed' classification refers to all areas that are forested and have not been harvested or disturbed by recent fires. The 'Cutblocks' class refers to all harvested areas. The 'Recent Burns' class refers to all areas that have been burned by the Mitsue or either of the Chisholm fires, excluding cutblocks. The 'Natural Non-Forested' class refers to areas that for natural reasons do not have forest type vegetation. This includes vegetated areas like grassy meadows and shrub areas, and non-vegetated areas including lakes, rivers and flooded areas. The 'Anthropogenic Non-Forested' class refers to areas that do not have forest type vegetation as a result of human influence. These areas include gravel pits, pipelines, wellsites, and crop and pastured land. The areas within each forest productivity class are displayed in. Map 5-3 displays the spatial distribution of these classes.

## 5.3.2 Operational Categories

The operational categories of 'Non-Operational', 'Protected', 'Unmerchantable' and 'Operational' are summarized in this section.

The FMA has been broken down into four distinct operational categories. The first category, 'Non-Operational', consists of watercourse buffers. The 'Protected' category represents all areas that are protected from timber harvesting such as disposition reservations that are not included in the net landbase. The 'Unmerchantable' category represents all areas where harvesting can not occur because the area does not contain enough merchantable timber. This category includes both unproductive areas and productive areas that do not currently meet the merchantability criteria. Anthropogenic Non-Forested areas are included in the 'Unmerchantable' operational category. The 'Operational' category consists of all stands that are currently merchantable, and do not fall into any of the other categories. The area of each forest productivity class is displayed in Table 5-3. The spatial distribution of these categories is displayed in Map 5-4.
